Holiday Bazaar rules

- Vendor space is reserved on a *first-come* basis. Early registration increases your chance of getting your preference. **Booth space selected by you during payment.**
- Full disclosure of items being sold must be made on the registration form.
- Please provide a photo representing items you will be selling. Upload during registration or email: bazaar@clevelandhigh.band
- No vendor will be allowed to sell food or beverages for immediate consumption. The Band Parent's Association will have a concessions area.
- All Johnston County Public Schools policies must be followed. Nothing explicit, obscene, vulgar or inappropriate will be sold. No alcohol, tobacco, e-cigarettes, or pets are to be brought onto school property.
- Each vendor is expected to provide a *raffle donation of at least a \$10 value* that appropriately reflects their business.
- Vendors can set up on Friday December 6th (6-8pm) or Saturday December 7th (7-9am).
- Vendors should park only in the designated area on Saturday to allow patrons to park closer.
- Vendors are to provide their own table(s), not to exceed the size of their vendor space.
- Vendors may not begin packing up their booth before 3pm.

- ❖ The event will be held in the Cleveland High School Auditorium side of the building, and extend to the cafeteria, 9:30 to 3pm, Cleveland High School, 1892 Polenta Road, Clayton, NC 27520
